We use your personal Information only for providing the services requested, improving the site, and to maintain appropriate company transaction records. By using the site, you agree to the collection and use of information in accordance with this policy.

## **Information Collection and Use**

## **Cookies**

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our site.

We take the privacy and security of personal information seriously and follow a strict protocol so that information is handled responsibly and in accordance with all applicable data protection and privacy laws.
